The Board acknowledged receipt of an annexation petition containing 14.202 acres from Hamilton Township to the Village of Maineville, Richard Paolo, Agent.

Ray Warrick, Warren County TEA Party Representatives, was present with various Tea Party members, to discuss their opposition to the proposed 1% increase in lodgings tax for the purpose of constructing a sports complex.

Phil Smith, Convention and Visitor's Bureau, gave the background information on the CVB and presented a PowerPoint presentation showing a rendering of the proposed park as well as the proposed economic benefits anticipated.

There was discussion relative to the proposed increase in lodgings tax and numbers TEA party members spoke in opposition to said increase.

Mr. Warrick reviewed the three principles of the TEA party and stated his opinion that the CVB will never hit the proposed numbers and revenue and stated the TEA party's opposition to the lodgings tax increase.

Mr. Warrick stated the TEA party's desire for the Board to utilize cash reserves to pay for any improvements to the building rather than borrowing money in this economy.
