On motion, bids were closed at 9:05 a.m. this 29th day of May and the following bids were received, opened and read aloud for Section St. Water Main CDBG Project Re-Bid for the Warren County Office of Grants Administration:

Jerry Haddix, Coordinator, Warren County Office of Grants Administration, will review bids for a recommendation at a later date.

Steve Hunt, Agent along with Richard Paolo, to annex 43.6812 acres to the Village of Maineville, was present along with representatives from Hamilton Township and the County Engineer's Office to consider the annexation petition filed pursuant to Ohio Revised Code Section 709.023 [a.k.a. Expedited Type 2 Annexation].

Mr. Hunt stated that this is the 3rd annexation of a three part annexation to Maineville and he will answer any questions that the Board may have relative to the petition.

Warren Ritchie, Attorney for Hamilton Township, stated that he understands that this petition is procedures in nature. He stated that he does not like the annexation law but understands that criteria the Board must consider. He stated that the Township has no idea if procedural compliance has been met before objections are statutorily due.

Commissioner Young questioned Mr. Hunt if this annexation is due to the township impact fee.

Mr. Hunt stated affirmatively. He stated that in a major housing decline, a \$6000 + impact fee makes a huge impact on a homebuyer.

There was discussion relative to the pending decision of the Ohio Supreme Court on whether property annexed under the expedited petitions for annexation are still subject to the impact fee due to the property remaining in the Township.

Commissioner Young then confirmed with the Clerk that all procedural requirements have been met in order to approve this petition for annexation.

Upon further discussion, the Board resolved (Resolution #12-0745) to approve the annexation of 43.6812 acres to the Village of Maineville, Richard Paolo, Agent, pursuant to Ohio Revised Code Section 709.023 [a.k.a. Expedited Type 2 Annexation].

Commissioner Young informed those present that the Board has settled the lawsuit relative to the Mary Klingling Trust. He stated that this settlement has cost the taxpayers a net of \$700,000 which in his opinion is ridiculous.

Mr. Young thanks Bruce McGary, Assistant Prosecutor, for his throughout and exhaustive work he has completed relative to this matter over the past five years and commended him of the fantastic job of defending the taxpayers of Warren County.

Commissioner South stated that this is a 144 year old trust that this Board of Commissioners inherited. She stated that this is a position that this matter is finally settled and no future Boards will have to deal with the matter. She then clarified that the settlement is closer to \$1 million when to take into consideration the cost to demolish the old building.

Commissioner Ariss stated his agreement with Commissioners Young and South and stated his opinion that Mary Klingling would be happy to see the \$700,000 going towards grants to non-governmental entities for the express benefit of Warren County children.

Mr. McGary clarified that the Board did receive ownership of an asset containing 53 acres at the resolution of this settlement.

On motion, upon unanimous call of the roll, the Board entered into executive session 10:10 a.m. to discuss personnel matters pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 12:02 p.m.

Upon motion the meeting was adjourned.
