#### **PUBLIC HEARING**

### SITE PLAN REVIEW APPLICATION OF WARREN COUNTY AIRPORT, LTD. / FORD DEVELOPMENT IN TURTLECREEK TOWNSHIP

The public hearing to consider the site plan review application of Warren County Airport, LTD /Ford Development in Turtlecreek Township was convened this 19<sup>th</sup> day of June 2012, in the Commissioners' Meeting Room.

Mike Yetter, Zoning Supervisor, reviewed the site plan review application, the location of the property and stated that the property is zoned "B-2" Community Commercial Business Zone. He stated that the airport plans to construct a commercial airplane storage facility to house 8 to 10 aircrafts with office space incorporated in the structure. He further stated that the current zoning allows for the proposed use.

Mr. Yetter reviewed the comments and recommendations from all departments and officials concerned and stated his recommendation to approve the site plan review application subject to six conditions.

Upon further discussion, the Board resolved (Resolution #12-0862) to approve the site plan review application subject to six conditions.
