The Board met this 24th day of October 2012, in special session to conduct a work session to discuss the I-75 Corridor as it relates to the location of a "racino" along Union Road and State Route 63 in Turtlecreek Township.

Commissioner Young reviewed the following items:

- 1. Distribution of proceeds from the tax increments financing (TIF) of the area What improvements will be paid for by the TIF and how much will the developer donate to Warren County towards the re-development of the Warren County Fairgrounds
- 2. Payment by Delaware North to Warren County towards the re-development of the current Warren County Fairgrounds
- 3. Joint Economic Development District Final details are being discussed between the City of Monroe and Turtlecreek Township—discussing the possibility of a "winning tax"
- 4. Water service provider (Warren County)
- 5. Union Road left turn and roadway realignment- proposed alignments were reviewed and Mr. Sultemeier stated his willingness to dedicate land but requested the new alignment be designed as close to their property line as feasible
- 6. Lease with Delaware North/Churchill Downs for racing at the fairgrounds
- 7. Payment for "past deferred maintenance" An agreement has been tentatively reached with the Warren County Agricultural Society
- 8. Site plan review public hearing will be scheduled upon approval by the Regional Planning Commission
- 9. Sales tax exemption
