DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Neil Tunison, County Engineer, was present to present an amendment to the Intergovernmental Agreement between the Warren County Transportation Improvement District and this Board relative to proposed project.

Mr. Tunison explained the need to amend the agreement to add the proposed road improvements needed along Union Road in front of the Solid Rock Church required by the increased traffic from the Racino and the proposed improvements to Wilkens Boulevard in Deerfield Township.

Mr. Tunison explained that the County has noted \$800,000 for the Union Road project and this agreement allows the project to be added as well as allocates \$750,000 towards the project.

Commissioner Young stated to those present that the County Engineer acts as a "pass through" for project funds.

There was discussion relative to various other needed safety and traffic improvements within the county including Bethany Road and Butler-Warren Road due to the Monroe Outlet Mall.

Upon further discussion, the Board resolved (Resolution #13-0950) to approve and enter into an Amendment of the Intergovernmental Agreement between this Board and the Warren County Transportation District, designating new projects and funding.

PUBLIC HEARING

CONSIDER TEXT AMENDMENT TO THE WARREN COUNTY ZONING CODE RELATIVE TO BOARDING HOUSES AND SLEEPING ROOMS

The public hearing to consider amendment to the Warren County Rural Zoning Code initiated by the Rural Zoning Commission was convened this 25th day of June 2013, in the Commissioners' Meeting Room.

Mike Yetter, Zoning Supervisor, explained that this text amendment came about due to a violation in Franklin Township. He stated that they were unable to determine the definition of Boarding House or Sleeping Room, creating the need for the text amendment in order to clarify.

Mr. Yetter stated that the proposed amendment will add "Boarding House" to the table of uses and the definition of Boarding House and Sleeping Room to the definitions.

Mr. Yetter stated that both the Regional Planning Commission and the Rural Zoning Commission recommended approval of the proposed amendments and no township trustees or residents objected to the proposed amendment.

Mr. Yetter stated that the Board House would only be allowed with a Conditional Use Permit in the R-3, B-1 or B-2 Zones as well as the mixed use zones.

There was discussion relative to the definition being more restrictive including the change of the maximum number of rooms from 5 down to 3 as well as the elimination of the words "with meals" in the Boarding House definition.

Commissioner South stated her desire for better wording in the definitions relative to the requirement for one kitchen as well as her desire to continue this public hearing to a later date.

Upon further discussion, the Board resolved (Resolution #13-0951) to continue the public hearing to July 16, 2013, at 9:30 a.m. in the Commissioners' Meeting Room.
