DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Mike Bunner, Emergency Services Director, gave a brief presentation relative to the exercise last week with the US Department of the Army.

Mr. Bunner stated that they learned a tremendous amount from the experience and felt the exercise helped identify critical infrastructure and will provide much needed data to help Warren County.

Chris Brausch, Sanitary Engineer, Warren County Water and Sewer Department will review bids for a recommendation at a later date.

On motion, upon unanimous call of the roll, the Board entered into executive session at 9:18 a.m. to discuss pending litigation pursuant to Ohio Revised Code Section 121.22 (G)(3), union negotiations pursuant to Ohio Revised Code Section 121.22 (G)(4) and personnel pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 10:59 a.m.

Chris Brausch, Sanitary Engineer, was present for a work session and discussed the following matters:

- 1. Hamilton County MSD Agreement—Hamilton County has approved the revised agreement. The Prosecutor's Office is reviewing the agreement which contains a few of the following:
 - a. There was a disagreement in the old agreement relative to what the user fees were and their fees are continuously increasing we currently pay \$5.98 per 1000 gallons
 - b. The new agreement is \$4.66 per 1000 gallons based on our user's water usage

The Board of Commissioners requested Mr. Brausch to following up via email with an executive summary and proceed with the processing of the agreement.

2. Mr. Brausch discussed a potential residential development along SR 42 in Union Township containing 460 acres and proposing 600 single family homes. He stated that Warren County has water approximately 3500 feet away and can service at a proposed cost of \$300,000. He stated that sanitary sewer is approximately 7000 feet away and the proposed cost is unknown at this time

Upon motion the meeting was adjourned.
