## DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Brad Ruwe, Dinsmore & Shohl, was present along with Matt Schnipke, Economic Development, to consider the legislative approval resolution required for the issuance of tax-exempt development revenue refunding bonds by the Warren County Port Authority relative to Bishop Fenwick High School.

Mr. Schnipke stated that the Port Authority will be re-issuing the bonds for this project that Butler County Port Authority had previously issued.

Mr. Ruwe explained the need for legislative authority and presented the draft resolution for consideration.

Upon discussion, the Board resolved (Resolution #15-1142) to grant authority for the issuance by the Warren County Port Authority of its developmental revenue refunding bonds (Bishop Fenwick Project), Series 2015, the proceeds of which will be used to refinance facilities owned and operated by Dennis M. Schnurr, Archbishop of Cincinnati, Trustee for Bishop Fenwick High School located within Warren County, Ohio.

Brian Sleeth, Warren County Board of Elections Executive Director, was present along with Deputy Director Shari Huff and Board Members Lori Viars, Bethe Goldenfield, and Kathlene Applegate for a work session to discuss their desire for the Board to create an election revenue fund.

Mr. Sleeth stated that Ohio Revised Code Section 3501.17 (H)(1) allows the Board of Commissioners to adopt a resolution to establish the requested fund. He then explained that the current voting equipment is reaching end of life and will need to be replaced sometime around 2017/2018. He stated that the election revenue fund will allow a fund to deposit charge back funds from the May special election (estimated at \$100,000) from the political subdivisions with issues on the special election ballot.

Mr. Sleeth stated that in 2005, the current equipment was purchased for \$1.8 million with HAVA funds from the State. He stated that the Board of Elections is trying to be proactive with the needed \$1.3 million for replacement which would require a set aside of approximately \$520,000 in 2016 and 2017 in order to have funds in place when the equipment replacement is necessary or when replacement is mandated by the State of Ohio.

Commissioner South commended the Board of Elections in being proactive and stated her appreciation for the desire to follow the philosophy of Warren County to have the money set aside and pay cash when the expenditure is needed.

Commissioner Young discussed the future voting process and stated his comfort level in being able to rely on a paper ballot.

Mr. Sleeth stated that Warren County has no plans to deviate from the paper ballot. The computer equipment proposing to be purchased will be tablets for the poll workers that will replace the paper voter registration sheets and the equipment that counts votes.

Tiffany Zindel, Deputy County Administrator, stated that the creation of this fund is a good way to plan ahead.

Matt Nolan, County Auditor, stated his support of the creation of the fund and that this will be a great first step in heading in the direction for a similar fund for the IT Department.

Commissioner Grossmann questioned the maintenance costs vs. the replacement cost.

Mr. Sleeth stated that the older the equipment gets, the higher the maintenance contract fee. He stated that the current fee is up to \$72,000 per year. He also stated that the equipment is constantly breaking down with fewer spare machines due to the current equipment being no longer available for purchase.

Upon further discussion, the Board stated their approval for the establishment of the Board of Elections Revenue fund and will further discuss during the 2016 budget process.

On motion, upon unanimous call of the roll, the Board entered into executive session at 10:12 a.m. to discuss personnel matters relative to new hires for Emergency Services, Human Services and Children Services pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 10:26 a.m.

Upon motion the meeting was adjourned.
