ADMINISTRATIVE HEARING CONSIDER VARIANCE AND APPEAL OF CONDITIONS REQUIRED FOR AN ACCESS PERMIT RELATIVE TO CROSS CREEK ESTATES SUBDIVISION IN DEERFIELD TOWNSHIP

The administrative hearing to consider the variance and appeal of conditions required for an access permit relative to Cross Creek Estates in Deerfield Township was convened this 29th day of March 2016, in the Commissioners' Meeting Room.

Jeff Hebeler, The Drees Company (applicant), was present and requested the Board to continue this administrative hearing for four weeks.

Upon discussion, the Board resolved (Resolution #16-0483) to continue the administrative hearing to April 26, 2016, at 9:30 a.m.

Matt Nolan, County Auditor, was present along with Ben Clift, Information Technology Director, and Connie Brennan, Programmer, for a work session to discuss the requirements needed in order to comply with the IRS requirements for ACA application for a Transmitter Control Code necessary in order to comply with the "Obamacare" regulations.

Ms. Brennan stated that the IT Department has completed all of the necessary recordkeeping but in order to set up a Transmitter Control Code with the IRS, they require three (3) individuals to set up a personal account that includes their own personal social security number as well as their personal IRS tax return information.

Tiffany Zindel, Deputy County Administrator, informed the Board of the estimated cost of \$1250.00 - \$1750.00 if this filing service is outsourced to an outside vendor in lieu of the numerous hours it will take for our Warren County IT Department to create the program necessary to transit our data to the IRS in the form they require.

Commissioner Young stated that is another reason why the government should not be involved in healthcare matters.

Upon further discussion, the Board directed staff to outsource the filing service.
