The Board met in special session this 1st day of September 2016, in the Commissioners' Meeting Room for the 100 year time capsule opening of the former County Infirmary, Dedicated September 2, 2016 and today known as the Warren County Health and Human Services Building located at 416 S. East Street, Lebanon, Ohio 45036.

Commissioner Young called the meeting to order with the Pledge of Allegiance and the Board of Commissioners presented welcoming comments to those in attendance.

Linda Oda, Warren County Recorder, presented a historical review of the County Infirmary and introduced Jennifer Haney, Director of the Warren County Records Center and Archives.

Ms. Haney introduced her staff and reviewed the journey that was following in finding the existence of the time capsule and the extraction from the building.

Ms. Haney then opened the time capsule, with the assistance of Jenifer Baker, Deputy Archivist, and displayed the contents for public viewing.

Some of the items contained within the time capsule were:

- 1. Letter from Leah Thompson (Daughter of the Infirmary Superintendent)
- 2. Photograph of J. A. Runyan Commissioner in charge of doing the original Time Capsule
- 3. Various photographs that are hard to distinguish as there is damage to the emulsion.

Pennies from 1898, 1903, 1911, 1913 and 1916 Quarter – 1892
