DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Neil Tunison, Warren County Engineer was present for a work session to discuss the possibility of the need to relocate fiber optic cables for two companies relative to the Mason-Montgomery Road Widening Project.

Mr. Tunison stated that in 2015 all known companies were notified of the need to relocate their utilities for the project. He stated that the two cables in question are attached to a Duke Energy utility pole and they have been unable to identify the companies that own the cables. He then stated that while his office is making every effort to identify the companies in question, he wanted to inform the Board that he may need authorization to enact ORC 5547.03 which enables the County to relocate the cables.

Susan Walther, Children Services Director, was present along with Shawna Barger, Deputy Director, for a work session to discuss the Ohio START (Sobriety Treatment And Recovery Teams) Program.

Ms. Walther stated that the state has recently expanded the program to include an additional four counties and stated her desire to apply to be considered for one of the four counties.

Ms. Walther explained that the START program is a child welfare led program which partners with local behavioral partners and is designed for families with co-occurring substance use and child maltreatment. She stated that a trained child welfare worker is paired with a family peer support specialist who is in long-term sobriety which provides intensive wraparound services to promote sobriety and increase parental protective capacities.

Ms. Barger explained that the grant is for up to \$125,000 with a 25% match from the County and that the new caseworker position in the 2018 budget would cover that 25% requirement.

Ms. Walther stated that the County would have the ability to withdraw from the program at any time it determines that the program is not effective.

Upon further discussion, the Board authorized Children Services to submit their application for the program.
