The Board discussed the revenue losses of the Warren County Sports Complex as it relates to the decisions being made from the Governor's Office as it relates to the loss of tournaments as well as the seven day reprieve of the ban in order to allow a basketball tournament to proceed due to a pending lawsuit.

#### PUBLIC HEARING

#### 2021 TAX BUDGET

The Board convened the public hearing to consider the 2021 tax budget this 14<sup>th</sup> day of July 2020.

Martin Russell, Deputy County Administrator, presented the follow information from the proposed tax budget:

2021 Tax Budget appropriation request 54% public safety 37.5% general operating 5.27% social service 2% miscellaneous and debt service .45% increase from 2020 Tax Budget

\$80,993,362.00

Mr. Russell stated that this budget includes the full weight of Children Services, the statutory salary increase to the newly/reelected county officials, staffing increases for the new jail, the continued plateau within DTAC and the ongoing maintenance of our 911 system.

Mr. Russell reviewed the current revenue projections as well as the challenges associated with fully anticipating revenue in order to budget due to CODID-19. He discussed the infrastructure bank set aside of \$7 million for 2020 and the going of \$35 million over the next five years that will need to be evaluated at the end of the year. He discussed the "rainy day fund" established in 2020 in the amount of \$12 million that will be evaluated at the end of the year for 2021 as it is limited to 16.6 % of the previous year expenditure.

Upon further discussion, the public hearing was closed and the Board resolved (Resolution #20-1008) to approve and adopted the 2021 Tax Budget.
