DISCUSSIONS

The Board opened the 2022 Annual Organizational Meeting, appointing the President and Vice-President of the Board, establishing the meeting dates and times and approving various appointments and reappointments.

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Susanne Mason, Program Manager within the Office of Grants Administration, was present along with Tim DeHart, President of AAA Wastewater in Franklin Township, Ohio, to discuss the company's request for the Warren County Solid Waste Management District to submit a Market Development Grant Application on their behalf.

Mr. DeHart gave background on his company and explained that they are seeking the grant to expand their current grease trap waste disposal services. He discussed the various types of disposal options for grease trap waste and explained how their process provides an environmentally friendly option to traditional disposal methods. He then explained that the grease solids are separated from the liquids and then recycled and sold as a reusable fuel source, stating that the liquids can then be disposed of in a sewer system or by land application.

Bruce McGary, Assistant Prosecutor, questioned whether this has been reviewed by the Sanitary Engineer as the liquid by-product could be disposed of into the sewer system.

Mr. DeHart stated that AAA Wastewater uses the land application disposal method and nothing would be disposed of in the County sanitary sewer system.

Upon further discussion, the Board resolved (Resolution #22-0040) to authorize the submission of a 2022 Market Development Grant to the Ohio Environmental Protection Agency on behalf of the Warren County Solid Waste Management District upon approval of legislation amendments by the Prosecutor.

Chris Brausch, Sanitary Engineer, was present to discuss the demolition of property located at 100 Hazen Avenue, Morrow, Ohio.

Mr. Brausch explained that the 0.5455-acre property was purchased in late 2021 for the planned future expansion of the Todds Fork Sanitary lift station, new flow equalization basin, and associated appurtenances and that the structure located on the property is abandoned and uninhabitable.

Commissioner Grossmann stated that he was contacted relative to the Morrow Village Administrator inquiring about the County utilizing a different property, rather than the Hazen Avenue property, for same purpose.

Mr. Brausch stated that he did look at the other property, but it did not suit the needs as well as the Hazen Avenue property.

Upon further discussion, the Board resolved (Resolution #22-0041) to authorize the demolition and removal of the building and contents at 100 Hazen Avenue, Village of Morrow.

Bruce McGary, Assistant Prosecutor, stated that he received a voicemail from the Morrow Village Administrator regarding the St. Zachary's Haven project that the Board had previously denied a request for expanding the sewer service boundary map. He explained that the owner of St. Zachary's Haven has reached out to the Village to discuss the possibility of annexation.

Chris Brausch, Sanitary Engineer, questioned if the property were to be annexed by the Village of Morrow, if the Board would be required to expand the boundary area and stated that the capacity for additional expansion does not exist at this time.

Mr. McGary stated that if the property is annexed, that the Board would have to consider the expansion on the merits of requested expansion but that it would be at the Board's discretion whether or not to approve the expansion request. He further stated that should the Board choose not include the St. Zachary's Haven project in the sewer service area, it would not prevent the project from moving forward with an on-site system.

Upon motion the meeting was adjourned.
