## DISCUSSIONS

On motion, upon unanimous call of the roll, the Board accepted and approved the consent agenda.

Martin Russell, Deputy County Administrator, was present to provide an update on the Middletown Multi-Use Entertainment Venue project.

Mr. Russell reviewed the authorization of the Board to utilize American Rescue Plan Act (ARPA) dollars through a partnership with the Warren County Port Authority and the City of Middletown for the purposes of a market demand, competitive analysis, and financial feasibility study related to the Middletown Multi-Purpose Entertainment Venue. He stated that the project is progressing well and starting to move quickly through the process. He stated that the goal of the development team is to be out to financing by the end of Q4 with an anticipated opening date

in the late summer of 2024. The study approved in partnership with the City of Middletown is moving into Phase 2 of the process.

Mr. Russell stated that he is asking that the BOCC approve a resolution authorizing the remainder of the \$3.5 million (over \$3.3 million) in the framework for this project be appropriated.

Upon discussion, the Board resolved (Resolution #22-1029) to authorize necessary documentation for the payment of American Rescue Plan Act funds toward the Middletown Multi-Use Entertainment Venue.

On motion, upon unanimous call of the roll, the Board entered into executive session to discuss hiring within Children Services at 9:03 a.m. pursuant to Ohio Revised Code Section 121.22 (G)(1) and exited at 9:07 a.m.
