**INVITATION TO BIDDERS**

Separate sealed bids for One Aluminum Box Culvert for Grog Run Road Bridge Replacement Project for the County Engineer will be received by the Warren County Board of Commissioners at the Office of the Warren County Commissioners until 10:15 a.m., March 4, 2008, and then at said time publicly opened and read aloud in the Commissioners Meeting Room at 406 Justice Drive, Lebanon, Ohio 45036.

Bid documents and specifications may be obtained at the Warren County Office of Management and Budget, 406 Justice Drive, Lebanon, Ohio. Questions regarding the technical specifications should be directed to the Warren County Engineer's Office, Attn: Roy Henson, at (513) 695-3310.

A Bid guaranty, as required by the Ohio Revised Code, Section 153.54, shall accompany each proposal submitted, as follows:

1. A Certified check, cashiers check, or letter of credit equal to five (5) percent of the bid. A letter of credit may only be revocable by the Owner. Upon entering into a contract with the Owner, the contractor must then file a performance bond for the amount of the contract and the bid guaranty will then be returned to the successful and unsuccessful bidders upon contract execution.

OR

2. A form of bid guaranty bond (attached) for the full amount of the bid. A bond is retained for the successful bidder, but returned to unsuccessful bidders after the contract is executed. Attention of bidders is called to all of the requirements contained in the bid packet.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

All bids shall be properly signed by an authorized representative of the bidder.

All bids shall be sealed and plainly marked "Bid Opening – One Aluminum Box Culvert for Grog Run Road Bridge Replacement Project, March 4, 2008 at 10:15 a.m."

Warren County reserves the right to reject any or all bids submitted, to waive any irregularities in bids, and enter into a contract with the Bidder who in Warren County's consideration offered the lowest and best bid.
