APPROVE NOTICE OF INTENT TO AWARD BID FOR FOOD SERVICE FOR THE WARREN COUNTY JAIL AND JUVENILE JUSTICE FACILITY TO ARAMARK CORRECTIONAL SERVICES LLC

WHEREAS, bids were closed at 10:30 a.m., March 16, 2010, and the results are on file in the Commissioners Office; and

WHEREAS, ABL Management and Canteen Correctional Services have indicated to the Warren County Sheriff's Office and the Juvenile/Probate Court, during the bid review process, that they are not interested in entering into a contract with Warren County for anything other than both facilities; and

WHEREAS, Aramark is the only vendor to indicate that they would do a split facility contract; and

WHEREAS, upon review of such bids by Sheriff Sims and Tony Brigano, Court Administrator for Juvenile/Probate Court, Aramark Correctional Services LLC., has been determined to be the lowest and best combined bid to provide Food Service for the Jail and Juvenile Justice Center; and

NOW THEREFORE BE IT RESOLVED, upon recommendation of Sheriff Sims, that it is the intent of this Board to award bid to Aramark Correctional Services LLC, 1101 Market Street, Philadelphia, PA, based on their alternate combined bid as follows:

180 – 200 inmates and staff at \$1.002 per meal plus an additional \$250.00 weekly administrative management fee if the population of inmates drops below 180

200 – 249 inmates and staff at \$1.002 per meal

250+ inmates and staff at \$0.949 per meal

Additional options were provide for preventive maintenance on equipment per meal, for a cost of \$0.010, repairs and maintenance on equipment per meal, for a cost of \$0.035 and replacement trays, cups, spoons, bowls, etc. per meal, for a cost of \$0.035; and

BE IT FURTHER RESOLVED, upon recommendation of Tony Brigano, Court Administrator for Juvenile and Mary Haven, that is the intent of this Board to award bid to Aramark Correctional Services LLC, as follow:

Juvenile and Staff meals at \$2.83 per meal

Juvenile snack at \$.45 per snack

BE IT FURTHER RESOLVED, that the President of the Board is hereby authorized to execute a "Notice of Intent to Award."

INVITATION TO BIDDERS

Separate sealed bids for the Food Service for the Warren County Jail will be received by the Warren County Board of Commissioners at the Office of the Warren County Commissioners until 10:00 a.m., March 16, 2010, and then at said time publicly opened and read aloud in the Commissioners Meeting Room at 406 Justice Drive, Lebanon, Ohio 45036.

Bid documents and specifications may be obtained at the Warren County Office of Management and Budget, 406 Justice Drive, Lebanon, Ohio. Questions regarding the technical specifications should be directed to Sheriff Larry Sims, Warren County Sheriff's Office, 550 Justice Drive, Lebanon, Ohio, (513) 695-1126.

A Bid guaranty, as required by the Ohio Revised Code, Section 153.54, shall accompany each proposal submitted, as follows:

1. A Certified check, cashiers check, or letter of credit equal to five (5) percent of the bid. A letter of credit may only be revocable by the Owner. Upon entering into a contract with the Owner, the contractor must then file a performance bond for the amount of the contract and the bid guaranty will then be returned to the successful and unsuccessful bidders upon contract execution.

OR

2. A form of bid guaranty bond (attached) for the full amount of the bid. A bond is retained for the successful bidder, but returned to unsuccessful bidders after the contract is executed. Attention of bidders is called to all of the requirements contained in the bid packet.

No bidder may withdraw his bid within sixty (60) days after the actual date of the opening thereof.

All bids shall be properly signed by an authorized representative of the bidder.

All bids shall be sealed and plainly marked "Bid Opening – Food Service for the Warren County Jail, March 16, 2010 at 10:00 a.m."

Warren County reserves the right to reject any or all bids submitted, to waive any irregularities in bids, and enter into a contract with the Bidder who in Warren County's consideration offered the lowest and best bid.
