The Warren County Probate Court can only correct Marriage Abstracts issued in Warren County, Ohio.

Corrections can be made in regards to the following:

- Name of Applicants
- Age of Applicants at time of application
- Birthplace of Applicants
- Name of Parents' of Applicants
- Previously Married information
- Date of marriage
- Name of Officiator

Evidence must be presented that verify the facts of the Marriage Abstract as of the date of issuance. The following form must be filed with the verification evidence:
